### General:

The meeting was called to order at 6:31 p.m. by President Hempson.

### Director's Report:

Director Marquis provided an overview of May and year to date activities and statistics. She reviewed the draft amended Patron Code of Conduct and a Smoking Guidance document regarding a new NYS Law. Trustee Conan provided an update and progress to date on the upcoming book sale. She indicated the pricing structure was being reviewed and there was still a need for volunteers to help at the sale.
